Refund Rules on cancellation of admission:

In the event of a student withdrawing before the start of the Course (11th July 2024), the entire Fee collected from the student, after a deduction of the processing Fee of not more than Rs.1000/- (Rupees One Thousand only) shall be refunded by the Institution.

In case a student leaves after joining the Course and if the vacated seat is consequently filled by another student by the last date of admission, the Institution will refund the Fee collected after a deduction of the processing Fee of not more than Rs.1000/- (Rupees One Thousand only) and proportionate deductions of monthly Fee and hostel rent, where applicable.

The last date for withdrawal of admission for the purpose of refund of fee should be as per the last date mentioned in the Academic Calendar (27th July 2024)

In case the vacated seat is not filled, the Institution shall refund only the Security Deposit and return the original documents.

2. The Candidate is requested to check the commencement date. The cancellation policy/date is applicable, as mentioned in the refund rule clause.
