### Pravin Dalal School of Entrepreneurship and Family Business Management Instruction Sheet - Integrated MBA Program for Family Business

#### 1. Eligibility Criteria/s:

- The Candidate must have passed the **10+2 or equivalent examination with 60% and above; in any stream at first attempt.**
- A candidate who has passed 10+2 or equivalent examination from **International Baccalaureate** Diploma (IB Certificate or / & DP awarded candidates with 24 credits compulsory and has passed 3 subjects at Higher Level (HL) with minimum (12 credits) and 3 subjects at Standard Level (SL) with minimum (9 credits) mandatorily from any stream.
- **Candidates of CBSE / ICSE**, should mention in the online registration / e-admission form (if selected) for 10+2 or equivalent examination, the aggregate marks of all the subjects the candidate has taken / opted and appeared for (not best of four, five, six or seven). The candidate shall have passed all the subjects he / she has taken / opted and appeared in the applicable examination/s in a single / first attempt. The aggregate percentage of all subjects the candidate has taken / opted and appeared will be taken into consideration for confirming eligibility of the candidate for the program at the time of admission.
- In case the mark sheet issued by the applicable Board / Institution is in percentile/s, the actual aggregate percentage of all the subjects appeared by the candidate will be taken into consideration.
- Candidates above 25 years of age are not eligible to apply.
- Those candidates who have passed or are appearing (all subject/s taken / opted) for 10+2 examination from a Board / University where Grade Point Average is given, such candidates must produce in writing from the Board / University concerned, the equivalent percentage for the GPA / CGPA obtained.
- **IB & Cambridge Candidate:** Candidates who do not have final mark sheet will be given "Provisional Admission" based on predicted scores. Fees will be accepted from such candidate but their admission will be confirmed on submission of final mark sheet before the commencement of the program if found eligible. The candidate shall have to submit copy of AIU notification to confirm their eligibility for the program as equivalent to (10+2) examination/s. The mark sheet/s / transcript/s issued by Board / University shall only be considered (the mark sheet/s / transcript/s issued by the School / Institute will not be considered / accepted.)
- International School/s candidates and those candidates who have completed their (10+2) or equivalent examination/s from overseas school/s / Institute/s / University will have to submit AIU certificate of equivalence (mandatory) to confirm their eligibility for the program as equivalent to (10+2) examination/s.
- Only single mark sheet with all compulsory subjects passed in first attempt is mandatory, no compartmentalized mark sheet will be considered

- The candidate who has NOT cleared the 10+2 or equivalent examination in the first attempt is NOT eligible to apply for the course.
- Candidate whose final mark sheet is not available at the time of admission are required to submit internet copy of result duly attested by Principal of the school / college, failing which candidate will not be admitted to the course.
- Candidate will not be eligible if any subject is marked as ungraded / fail in the mark sheet / grade sheet. For absent / ungraded in any of the additional / non mandatory subject will be consider as eligible provided such candidate is declared as passed by respective board.
- Good communication skills
- Basic understanding of their respective family run business
- Zeal to learn and take higher responsibility

Candidate has to fulfill all the above mentioned criteria's

**2. Duration of Programme:** 5 years, post 12<sup>th</sup> (10+2)

**3. In take capacity:** 60 students

**4. Online Registration and Registration Fee:**

Online Registration Fee is Rs. 3,000/- plus taxes (non-refundable)

**5. Payment of Registration Fee:**

Payment of registration fee can be made by Credit Card (Visa / Master).

**6. Selection Process:**

- The Institute will assess the suitability of the student, based on the information provided in the application form
- The applicant will have to go through a rigorous personal interview conducted by a panel, consisting of faculty members of the Institute.
- The focus will remain on the following:
  1. Communication Skills
  2. General awareness
  3. Basic Business Know-how
  4. Zeal to Learn
  5. Consistency in Thinking

There will be **no admission test**.

**7. Submission of Documents:**

Please upload below mentioned list of document using the link given in Call letter. It is important and primary requirement to upload the mandatory documents before Entrance test.

- Self-attested copies of 10<sup>th</sup> and (10+2) or equivalent mark sheet and certificate
- Self-attested copies of achievements in any other co-curricular / extra-curricular activities

**8. Fees :**

The fees for first year Integrated MBA program for Family Business - Batch 2019 were Rs. 6,27,500/- p.a.

The fees for 2020 Batch will be announced during personal interview.

- 9. Please note that it is responsibility of the candidate to check whether he/she is eligible to apply for the Program as per the eligibility criteria declared on the website. NMIMS has full right to disqualify a candidate at any stage of admission process if found ineligible. In such case, the admission of the candidate even if selected and fees paid stands cancelled and the fees paid will be forfeited.**
10. University has full right to disqualify a candidate at any stage of admission process if found ineligible. No separate intimation will be given.
11. Please refer the important dates and preserve it as a guide. All announcements from the University will be through its web site [www.nmims.edu](http://www.nmims.edu) and there will be no separate email sent.
12. For cancellation/ withdrawal of admission: Withdrawal /cancellation means voluntary withdrawal/cancellation by candidate for any reason.
