**Refund Rules on cancellation of admission:** If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees*	Point of time when notice of withdrawal of admission is served to HEI
(1)	<b>100%</b>	15 days or more before the formally-notified last date of admission. <b>(on &amp; before 17<sup>th</sup> July'2023)</b>
(2)	<b>90%</b>	Less than 15 days before the formally-notified last date of admission. <b>(18<sup>th</sup> July – 02<sup>nd</sup> August'2023)</b>
(3)	<b>80%</b>	15 days or less after the formally-notified last date of admission. <b>(03<sup>rd</sup> August – 17<sup>th</sup> August'2023)</b>
(4)	<b>50%</b>	30 days or less, but more than 15 days, after formally-notified last date of admission. <b>(18<sup>th</sup> August – 01<sup>st</sup> September'2023)</b>
(5)	<b>00%</b>	More than 30 days after formally-notified last date of admission. <b>(02<sup>nd</sup> September'2023 Onwards)</b>

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount, subject to a maximum of Rs 5,000/-.
