**Refund Rules on cancellation of admission:** The Schedule of refund of fees will be as follows as per UGC rule October 2018.

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees*	Point of time when notice of withdrawal of admission is served to HEI
(1)	100%	15 days or more before the formally-notified last date of admission <b>(on or before 15<sup>th</sup> June 2020)</b>
(2)	90%	Less than 15 days before the formally-notified last date of admission. <b>(i.e. from 16<sup>th</sup> June 2020 to 1<sup>st</sup> July 2020)</b>
(3)	80%	15 days or less after the formally-notified last date of admission <b>(i.e. from 2<sup>nd</sup> July 2020 to 16<sup>th</sup> July 2020)</b>
(4)	50%	30 days or less, but more than 15 days, after formally-notified last date of admission <b>(i.e. 17<sup>th</sup> July 2020 to 31<sup>st</sup> July 2020)</b>
(5)	00%	More than 30 days after formally-notified last date of admission <b>(i.e. from 1<sup>st</sup> August, 2020 onwards)</b>

\* Inclusive of course fees and non-tuition fees but exclusive of caution money & security deposit.

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount, subject to a maximum of Rs 5,000/-.
