Refund Rules on cancellation of admission

The Schedule of refund of fees will be as follows:

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees* remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees*	Point of time when notice of withdrawal of admission is served to HEI
1	100%	15 days or more before the formally-notified last date of admission
2	90%	Less than 15 days before the formally-notified last date of admission
3	80%	15 days or less after the formally-notified last date of admission
4	50%	30 days or less, but more than 15 days, after formally-notified last date of admission
5	00%	More than 30 days after formally-notified last date of admission

In case of (1) in the table above, the HEI concerned shall deduct an amount not more than 5% of the fees paid by the student, subject to a maximum of Rs. 5,000/- as processing charges from the refundable amount.

Note:

Please note the closure of admission / last date of admission as mentioned in the important dates of the respective programme. Candidates to refer Important Dates of the respective programme.

4. I, fully understand that the Vice Chancellor / Registrar, of the NMIMS University or the competent authority will have full liberty to expel and/or debar me from the Institute if I am proved guilty of using unfair means during examination, admission process etc.
