<u>Refund Rules on cancellation of admission</u>: The Schedule of refund of fees will be as follows as per UGC rule October 2018.

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees*	Point of time when notice of withdrawal of admission is served to HEI
(1)	100%	15 days or more before the formally-notified last date of admission (on or before 10 <sup>th</sup> June 2019)
(2)	90%	Less than 15 days before the formally-notified last date of admission. (i.e. from 11 <sup>th</sup> June 2019 to 26 <sup>th</sup> June 2019)
(3)	80%	15 days or less after the formally-notified last date of admission (i.e. from $27^{th}$ June 2019 to $11^{th}$ July 2019)
(4)	50%	30 days or less, but more than 15 days, after formally-notified last date of admission (i.e. 12 <sup>th</sup> July 2019 to 26 <sup>th</sup> July 2019)
(5)	00%	More than 30 days after formally-notified last date of admission (i.e. from 27 <sup>th</sup> July, 2019 onwards)

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount, subject to a maximum of Rs 5,000/-.
