Refund Rules on cancellation of admission : The Schedule of refund of fees will be as follows as per UGC rule October 2018.

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

| Sr. No. | Percentage of Refund of Aggregate fees* | Point of time when notice of withdrawal of admission is served to HEI |
|---------|---|---|
| (1) | 100% | 15 days or more before the formally-notified last date of admission (on or before 8th June 2020) |
| (2) | 90% | Less than 15 days before the formally-notified last date of admission. (i.e. from 9th June 2020 to 24th June 2020) |
| (3) | 80% | 15 days or less after the formally-notified last date of admission (i.e. from 25th June 2020 to 9th July 2020) |
| (4) | 50% | 30 days or less, but more than 15 days, after formally-notified last date of admission (i.e. 10th July 2020 to 24th July 2020) |
| (5) | 00% | More than 30 days after formally-notified last date of admission (i.e. from 25th July, 2020 onwards) |

* Inclusive of course fees and non-tuition fees but exclusive of caution money & security deposit.

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount, subject to a maximum of Rs 5,000/-.

Note: The above refund rules are subject to revision as per UGC notification (as applicable).
