1. **Introduction:** MBA- Entrepreneurship is specifically designed for students who want to lead and manage business enterprises and those who want to start their own ventures. This course will help students to learn fundamentals and acquire skill sets that will prepare them from initial development of a business plan, to financing a start-up and managing a growing business. This programme further helps the students in identifying business opportunities; apply design thinking, risk assessment and providing solutions for emerging markets.
2. **Program :** MBA (Entrepreneurship) 2 Years program
3. **In take capacity:** Will be updated at the time of admission

\*Program will commence only if there are a minimum of 10 eligible candidates admitted after the selection process.

4. **Eligibility Criteria:**

- Bachelor's Degree in any discipline from Recognized university (**Minimum 50% in Aggregate**)
- Good oral and written communication skills
- No Business background required
- Total commitment to self-improvement

Those candidates who have obtained their degree by doing a part-time course or through distance learning, correspondence courses, externally, open school from recognized University are eligible to apply and register as per UGC guidelines

- Test : 20 Questions & 40% weightage
- Personal Interview : 60% weightage

Merit list will be prepared based on Test & Personal Interview score

## 8. Important Instructions:

- Please note that it is responsibility of the candidate to check whether he / she is eligible to apply for the Program as per the eligibility criteria declared on the website.
- The candidate must have appeared for all his subject(s) / exams before the commencement of the respective program (s) of NMIMS (Deemed to be University). The examination of none of the subjects should be held after the commencement of the respective course.
- Candidates whose final mark sheet of the qualified examination is not available at the time of their provisional admission, is required to submit their final marksheet copy as soon as the result declared. In such case, if the candidate fail to meet the required eligibility criteria then his admission will be cancelled and the fees will be refunded as per NMIMS refund rules (even after course commencement).

- NMIMS has full right to disqualify a candidate at any stage of admission process if found ineligible. In such case, the admission of the candidate even if selected and fees paid stands cancelled and the fees paid will be refunded as per refund rule.
- Please refer the important dates and preserve it as a guide. All announcements from the University will be through its web site [www.nmims.edu](http://www.nmims.edu) and there will be no separate email sent.
- Admission to program is considered as “**Provisional Admission**” till all required and mandatory documents are submitted by the candidate and the same is verified and approved. If it is found that the candidate is not eligible at any stage (even after the course commencement), admission will be cancelled and fees will be refunded as per refund rule clauses even if selected/ admitted to the program.
- AIU certificate is mandatory for those candidates who have completed their graduation from overseas Universities
- **For cancellation/ withdrawal of admission:** Withdrawal / cancellation means voluntary withdrawal / cancellation by candidate for any reason. Candidate has to upload cancellation form duly filled and signed, fees paid receipt copy & cancelled cheque (personal account) to mentioned link : <https://upload.nmims.edu/admission/cancellation/>
