1. **Introduction:** The MBA (Entrepreneurship & Family Business) Program at NMIMS was initiated in 1999, to help meet the unique needs of family business owners and managers. The objective of the program is to assist family-owned businesses in understanding the changing dynamics of competition as well as organization, brought about by liberalization, privatization and globalization. The Program intends to build a partnership between family business owners, managers and NMIMS.
2. **Program :** MBA Entrepreneurship & Family Business , 2 Years program
3. **Eligibility Criteria: :** It is the sole responsibility of the candidate to check his/her eligibility before applying for the course
  - Bachelor's Degree in any discipline from Recognized university (**Minimum 50% in Aggregate** )
  - Good oral and written communication skills
  - Actual involvement in running of family business
  - Total commitment to self-improvement

Those candidates who have obtained their degree by doing a part-time course or through distance learning, correspondence courses, externally, open school from recognized University are eligible to apply and register as per UGC guidelines

5. **Selection Process: -**
  - Test : 20 Questions , 20 marks & 40 marks weightage
  - Personal Interview (30 marks ): 60 marks weightage

Merit list will be prepared based on the marks obtained / Weightage in Test & Personal Interview score

The Candidate is requested to check the commencement date. The cancellation policy/date is applicable as the refund rule clause mentions

#### 8. Important Instructions:

- Please note that it is responsibility of the candidate to check whether he / she is eligible to apply for the Program as per the eligibility criteria declared on the website.
- The candidate must have appeared for all his subject(s) / exams before the commencement of the respective program (s) of NMIMS (Deemed to be University). The examination of none of the subjects should be held after the commencement of the respective course. If selected, provisional admission will be given subject to clearing the final examination. Fees will be accepted from such candidates but their admission will be confirmed on the submission of final mark sheet on or before 30th September'2026. The candidate's admission will be revoked, if they fail to present the mandatory document as specified.
- Candidates whose final mark sheet of the qualified examination is not available at the time of their provisional admission, is required to submit their final marksheet copy as soon as the result declared. In such case, if the candidate fail to meet the required eligibility criteria then his admission will be cancelled and the fees will be refunded as per NMIMS refund rules (even after course commencement).
- NMIMS has full right to disqualify a candidate at any stage of admission process if found ineligible. In such case, the admission of the candidate even if selected and fees paid stands cancelled and the fees paid will refunded as per refund rule.
- Please refer the important dates and preserve it as a guide. All announcements from the University will be through its web site [www.nmims.edu](http://www.nmims.edu) and there will be no separate email sent.
- Admission to program is considered as **"Provisional Admission"** till all required and mandatory documents are submitted by the candidate and the same is verified and approved. If it is found that the candidate is not eligible at any stage (even after the course commencement), admission will be cancelled and fees will be refunded as per refund rule clauses even if selected/ admitted to the program.
- AIU certificate is mandatory for those candidates who have completed their graduation from overseas Universities(Full time / Part time / online mode)
- All matters of dispute will be subject to the legal jurisdiction of Mumbai only.
- The admission information handout's eligibility requirements will serve as the only document for program eligibility. School's brochure or prospectus will only be used as a guide and not be used to refer eligibility.

- If a candidate is found ineligible even after commencement of the program, he / she would be discontinued from the program and fees will be paid in accordance with standard procedure.
- If at any stage of the program, it is found that a candidate does not satisfy the eligibility criteria or the information furnished by him/her in the application form is incorrect, his/her admission to the course, even if selected/ admitted, will stand cancelled and fees will be refunded as per refund rule clause. Candidates' admission will be canceled by the university if they do not voluntarily withdraw
